

Vaccinations against COVID-19 for self-payers and foreigners – update as of 16 May 2022

Any EU citizen or third country citizen who meets at least one of the following conditions may be vaccinated free of charge in the Czech Republic since 15 November 2021:

- has a valid long-term residence permit in the Czech Republic,
- holds a valid long-stay visa,
- is an EU citizen with a certificate of temporary residence on the territory of the Czech Republic,
- is a family member of an EU citizen with a certificate of temporary residence on the territory of the Czech Republic.

The condition is that individual stays are allowed for at least 90 days. These four groups do not have to pay for the vaccine as of 16 May 2022; however, they may be required to pay for the vaccination (the recommended price is CZK 400 maximum).

HOW TO CLAIM REIMBURSEMENT FROM SLAVIA POJIŠŤOVNA?

Slavia pojišťovna will cover the costs associated with vaccination for all its clients who have the **Comprehensive Health Insurance for Foreigners with a validity of at least 90 days**. The application for reimbursement of the costs of vaccination will be accepted only after the completion of the basic vaccination schedule, i.e. after the second dose. Each additional booster dose will then be reimbursed by Slavia separately. You can also request the reimbursement of all these doses at once.

How should the insured client proceed?

1. Register for the vaccination on <https://registration.mzcr.cz/>.
2. If you are asked to pay for the costs of carrying out the vaccination at the vaccination centre, a proof of payment must be issued.

3. After applying the second or booster dose, please contact Slavia pojišťovna with a request for reimbursement of the costs associated with the vaccination.

Send the application together with the original proofs of payment by post to the headquarters of the insurance company: Slavia pojišťovna a.s., Táborská 940/31, 140 00 Prague 4, Czech Republic.

Please attach the following to your application:

1. Application – the form can be found in Czech, English and Russian on the insurance company's website in the LIDÉ/FORMULÁŘE KE STAŽENÍ/CIZINCI section

2. Original receipts for the second or each additional booster dose
 3. Vaccination certificate (a copy of the certificate) or medical report
